1. The nominee must have made a special contribution to the profession of Pharmacy either on a local, provincial or national level.
2. The nominee must be a member of the Pharmacists' Association of Saskatchewan (PAS) and a member in good standing of the Saskatchewan College of Pharmacists.
3. Nomination papers must be accompanied by a summary of the qualifications of the nominee consistent with the Terms of Reference.
4. Nominations must be received in the PAS office by **February 28th, 2011**.
5. The selection will be made by members of the 2011 Conference Committee.
6. When possible, the PAS/GSK PHARMACIST OF THE YEAR will be presented at the Annual Conference of the Pharmacists' Association of Saskatchewan.
7. Recipients will receive a suitable engraved plaque or equivalent.
8. In the case where a group of pharmacists are nominated for a single contribution, only one award will be presented on behalf of the group.
9. The PAS/GSK PHARMACIST OF THE YEAR award does not necessarily have to be presented in any given year.

3. Are members of the Pharmacists' Association of Saskatchewan and members in good standing of the Saskatchewan College of Pharmacists.
4. Are interested in learning about PAS Board activities.
5. Are available to attend the PAS 10th Annual Conference, April 29th - May 1st, 2011

Procedures:

1. Interested candidates should complete the form attached, and mail or fax it to the PAS office, to be received **February 28, 2011**
2. Consideration will be given to candidates who meet the above noted criteria.
3. If necessary, the selection process will also consider geographic location to ensure representation from different areas of the province, and practice type to enable participation from diverse practice settings if possible.
