

Lecturer – pharmacology for nursing and pharmacy students and pharmacy practice

The College of Pharmacy and Nutrition invites applications from qualified individuals for a full-time Lecturer without Term position in the Division of Pharmacy. The successful candidate will teach pharmacology/pharmacy related subjects in the Doctor of Pharmacy program, as well as the College of Nursing and the School of Rehabilitation Science. The successful applicant will coordinate and teach Pharmacology for Nursing to students in the Bachelor of Science in Nursing and the Post-Degree BSN programs. Further responsibilities include instructing in the areas of pharmacology to pharmacy and physical therapy students, and other pharmacy-related subjects. These teaching responsibilities will occur over the entire calendar year.

Qualifications

A minimum of a Bachelor's degree in pharmacy or an entry-to-practice PharmD is required. To qualify, the candidate must be a licensed pharmacist in Saskatchewan by the Saskatchewan College of Pharmacy Professionals. Pharmacists who possess a current license in another Canadian province are eligible if they can obtain their Saskatchewan pharmacist license within 6 months of appointment date. We seek a candidate who has effective teaching, interpersonal, and communication skills. Preference will be given to candidates with previous relevant teaching and clinical experience.

The salary band for a Lecturer position is \$77,613 to \$115,245. Pay will be commensurate on experience. This position includes a comprehensive benefits package which includes a dental, health and extended vision care plan; pension plan, life insurance (compulsory and voluntary), academic long term disability, sick leave, travel insurance, death benefits, an employee assistance program, a professional expense allowance, and a flexible health and wellness spending program.
